

When replacing a fuse, make sure to use the correct type and amperage. Using an incorrect fuse could cause damage. The unit uses (1) 15 amp ATC mini style fuse located on the power connector

# Wiring Notes:


The Subwoofer preamp audio output (Green RCA) is active in all audio modes.

Rear camera input A rear view camera (not included) can be used with the Camera input

# Installation

## **Before You Start**

 Disconnect negative battery terminal. Consult a qualified technician for instructions. Avoid installing the unit where it would be subject to high temperatures, such as from direct sunlight, or where it would be subject to dust, dirt or excessive vibration.



\* Use 2 or 3 screws to affix the monitor to the bracket.

- 3 VOL+ 4 Power/Mute



# **Bluetooth Operation**

## Before using Bluetooth

Before you can use a Bluetooth device to make hands-free calls or stream audio. it must be authenticated. This is also referred to as "pairing" a device.

## Pairing a New Device

The unit broadcasts the pairing signal constantly when no devices are currently connected. Complete the pairing sequence from your Bluetooth device. Refer to the owner's manual for your device for more details. The device name is "DMCPA70BT". The unit can be in any mode of operation when pairing is performed. On certain phones, pairing may need to be done more than once.

The head unit will automatically connect to the last connected device when the connect feature is set to Auto connect On. If the connect feature is set to Auto Connect Off, the head unit will not automatically connect to any device.

From the main menu. touch the Bluetooth on the screen Bluetooth icon will appear anytime a Bluetooth device is cor nected.

Press to display keypad and dial a number.

# Press to connect a call, and press nto end a call.

Making and Ending a Call

**Transferring Audio** Press I to transfer audio between the head unit and mol phone.

# **Streaming Audio**

Press /II to play or pause the music.

# Press I to skip to the previous track.

Press ▶| to advance to the next track.

# Audio Operation

Press the Settings icon on the main menu screen to adjust Fader and Balance controls, Equalizer (8-Band Tone Control and 8 Presets EQ Settings).





# **Apple CarPlay Operation**

If the iPhone is connected via USB port, press Apple CarPlay icon on main menu to mirror the iPhone's apps onto the screen. If the iPhone USB cable is inserted to the USB port then the DMCPA70BT will automatically change to

# Select Android Auto on the Main Menu.




