

When replacing a fuse, make sure to use the correct type and amperage. Using an incorrect fuse could cause damage. The unit uses (1) 15 amp ATC mini style fuse located on the power connector.

Subwoofer outputs


The Subwoofer preamp audio outputs (Blue jacket with Black RCA) is active in all audio modes.

### Installation

**Before You Start** 

 Disconnect negative battery terminal. Consult a qualified technician for instructions. Avoid installing the unit where it would be subject to high temperatures, such as from direct sunlight, or where it would be subject to dust, dirt or excessive vibration.

- 3 Power/Volume/Mute A Previous Button 5 Next Button 6 RESET / USB Port




### Main Menu

# **Bluetooth Operation**

#### Before using Bluetooth

Before you can use a Bluetooth device to make hands-free calls or stream audio. it must be authenticated. This is also referred to as "pairing" a device.

The unit broadcasts the pairing signal constantly when no devices are currently connected. Complete the pairing sequence from your Bluetooth device. Refer to the owner's manual for your device for more details. The device name is "DCPA91". The unit can be in any mode of operation when pairing is performed. On certain phones, pairing may need to be done more than once.

The head unit will automatically connect to the last connect device when the connect feature is set to Auto connect On. If the connect feature is set to Auto Connect Off, the head unit will not automatically connect to any device.

#### **Bluetooth Phone**

From the main menu, touch the Bluetooth on the screen Bluetooth icon will appear anytime a Bluetooth device is cor

Press I to transfer andio between the head unit and mob


### Streaming Audio

### Audio Operation

Press the Settings icon on the main menu screen to adjust Fader and Balance controls, Equalizer (8-Band Tone Control and 8 Presets EQ Settings).





### CarPlay Operation

Select CarPlay on the Main Menu.

If the iPhone is connected via USB port, press CarPlay icon on main menu to mirror the iPhone's apps onto the screen. If the iPhone USB cable is inserted to the USB port then the DCPA91 will automatically change to CarPlay

## Android Auto Operation

Select Android Auto on the Main Menu.

If the Android Phone is connected via USB port, press Android Auto icon on main menu to mirror the Android Auto Basic Image onto the screen. If the Android Phone USB cable is inserted to the USB port then the DCPA91 will automatically change to Android Auto mode.

### **General Operation**

From the Main Menu screen, select Setup to access the Settings menu and select from categories represented by the icons on the bottom of the screen: General, Audio, Display, Others. Select the category, and adjust any of the available options using the touch screen
